The Public auction for cutting and lifting of Dry Acacia Wood trees spread over in the Campus premises, in as is where is condition, on weight basis in the Dravidian University Campus is fixed on 20.01.2020 at 3.30 P.M to be held in the premises of Guest House, Dravidian University with the following terms and conditions.

Terms and Conditions:

- 1. The interested bidders in public auction must posses licence of timber business from Forest Department, Government of Andhra Pradesh and should furnish a copy of it as proof and only such firms will be permitted to participate in the auction.
- 2. The bidders may inspect the dry acacia wood trees before participation of auction during office hours with the knowledge of Engineer-in-Charge.
- 3. Any eligible person or firm intending to bid must deposit a sum of Rs. 5,000/- (Rupees five thousand only) (not refundable) towards participation charges and EMD Rs.1,00,000/- (Rupees one lakh only) to be paid at the time of auction.
- 4. The highest bidder's bid will be accepted over and above of the minimum rate fixed by the University @ Rs.6,000/- (Rupees six thousands only)per ton including 18% GST.
- 5. The EMD deposited by other than highest bidders will be returned to them at the end of the auction.
- 6. The Registrar is having right for rejection or cancellation of any auction without assigning any reason.
- 7. The successful bidder should remit the FSD amount of Rs. 1,00,000/- (Rupees one lakh only) in the University account within 7 days after receiving of communication of bid acceptance letter amount and enter into a MOU/Agreement with the Registrar, Dravidian University and submit the challan to office of the Deputy Executive Engineer.
- 8. Cutting and lifting of Dry Acacia Wood trees, in as is where is condition, on weight basis is permitted only after concluding MOU/Agreement.
- 9. In the event of failure on the part of successful bidder to comply with the above conditions, the sale stands cancelled and resale will be held and the EMD paid by the successful bidder will be forfeited.
- 10. At any point of time, there shall always be an amount of Rs. 2,00,000/- (Rupees two lakhs only) available inclusive of EMD&FSD with the University during the period of disposal of the wood. That is, for each load of wood taken, the relevant amount shall be remitted to the University based on the weighment. At the time of final settlement, the amount of Rs. 2,00,000/- (Rupees two lakhs only) will be adjusted to the final amount of quantity of wood taken by you.
- 11. The period of completion to cutting and lifting of Dry Acacia Wood trees is one month only.

- 2. The dry wood is available at the University premises and the bidders may inspect the lots before auction date during office hours with the knowledge of authorities.
- 3. Any eligible person or firm intending to bid must deposit a sum of Rs. 2,000/- (Rupees two thousands only) (not refundable) towards participation charges and EMD Rs.10,000/- (Rupees ten thousands only) to be paid at the time of auction.
- 4. The highest bidder's bid will be accepted over and above of the minimum rate fixed by the University @ Rs.5,000/- (Rupees five thousands only) per ton including 18% GST.
- 5. The EMD deposited by the unsuccessful bidders will be returned to them at the close of the auction.
- 6. The successful bidder should remit the full amount in the University account (duly deducting the amount of EMD) within 7 days of communication of acceptance of the bid amount and submit the challan to office of the Deputy Executive Engineer and make necessary arrangement to take away the dry wood.
- 7. In the event of failure on the part of successful bidder to comply with the above conditions, the sale stands cancelled and resale will be held and the EMD paid by the successful bidder will be forfeited.
